# **PUBLIC POLICY**

 A Report from Richmond: Anti-Huan Trafficking Legislation

As most of you know, the Alexandria VA branch of AAUW is committed to advancing the cause of anti-human trafficking efforts in the Commonwealth of Virginia. One facet of this effort is focusing on anti-human trafficking legislation, especially those bills in-process through the Virginia General Assembly. There are six (6) anti-human trafficking bills which were approved by the legislature this legislative session. Three (3) of those bills have been approved by the Governor. See the chart below for a recap of this legislation.

HB 744	Requires a court to consider a juvenile's adverse life experiences when sentencing as an adult. When a juvenile is tried as an adult, a court may depart from any mandatory minimum sentence.	Both signed on 03/05/2020	Yes. Effective on 07/01/2020.	
HB 806	Adds a medical perspective to human trafficking and the treatment of its victims, and to the processing of claims for H.T. compensation	03/18 Signed by President. 03/19 Signed by Speaker.	Pending. Governor's action deadline April 11 2020	
SB 991	Establishes the Office of New Americans to implement a statewide strategy to promote immigrants' integration within the Commonwealth.	Both signed on 03/03/30	Pending. HB 1336	Provides for prevention of human trafficking to be integrated into the family life education offered in grades kindergarten thru 12.	03/06/2020	Pending. Governor's action deadline 04/11/2020
