### **PUBLIC POLICY**

Since AAUW's founding in 1881, education has been of primary importance in our mission. Therefore we decry the weakening of the Department of Education. While an executive order cannot destroy a Congressionally authorized department, it can severely hurt its capacity to function. Public education has been one of the comprehensive areas that has created the modern United States by giving all young people a chance to learn and contribute to American society. Student loans have been moved to the Small Business Administration which has received significant force reductions of 2,700 positions out of 6,500 personnel. There are new restrictions on student loan forgiveness. The Civil Rights Dept. has been severely decimated and its remains may go to the Dept. of Justice. Pell Grants may go to the Treasury and graduate scholarships may go away. Title IX may go to Health and Human Services and the rules have returned to the 2020 DeVos rules which said that sexual harassment must be severe and pervasive, a very high bar. It is anticipated that there will be soaring class sizes, the elimination of job training programs, higher education out of reach for many, and the Individuals with Disabilities Education Act (IDEA) services limited.

Social Security Medicaid and Medicare are three important indicators of women's financial security. In the recent Continuing Resolution, there was an over \$880 billion cut, almost all of it will come from Medicaid. Medicaid funds senior housing, including long term care, rural hospitals and 40% of all children's health. There is a push to privatize Medicare. Social Security has had major operational changes. Starting March 31<sup>st</sup>, the customer service phone line will be discontinued. New applicants and anyone making changes to their direct deposit will have to either do it online or go to a Social Security Administration office. Unfortunately, dozens Social Security offices are scheduled to be closed even with the tighter identity-proofing measurements. If the SAVE Act is passed, married women who have changed their name with have to have a passport, Real ID (driver's license with a star), or notarized birth certificate and marriage document.

Including postal workers, there are approximately 193,000 Federal workers in Virginia and 3.0 million in the United States that will have coverage under the unemployment insurance act. However, that is deceptive. Federally filed claims have reporting delays of several weeks or months because a claim is not classified as a federal claim until federal wages are confirmed. As many were fired with the claim that their work was unsatisfactory, they may not be eligible for unemployment. In total there are approximately 300,000 Virginians who work at Federal jobs or 10% of Virginia's workforce. It could create a 40% cut of GDP for the Commonwealth. If there is a 75% reduction in the workforce as stated, the unemployment rate will increase in the DC Metro area to 9.6%. In Alexandria, there are 9,021 full-time and part-time federal civilian employees or 11.2% of the workforce. There will be impacts on the Metro, Medicaid, SNAP, Federal Real Estate, population growth and immigration. Additionally, it is expected that 40% of restaurants and other hospitality units in this area will close. There is about only a 30%

match of jobs available at this time. The majority of those 160,000 listed jobs on the Virginia website are those that require advanced degrees or entry level sales clerks.

Three Virginia bills that AAUW supported, the increase of the minimum wage to \$15 per hour, removing salary history, and paid sick leave, were vetoed. Several bills supporting IDEA in education were passed, as were the bills forbidding restraints on juveniles in court without a hearing and a pilot program for remote care for maternity patients passed. A few of the bills (SB 1002, HB 2165) controlling the use of campaign funds passed, for the first time. Ranked choice voting adjustment (SB 1009) failed.

#### AAUW Condemns Executive Order to Dismantle the U.S. Department of Education

March 20, 2025

Action Jeopardizes Students' Futures; Congress Should Not Allow Further Cuts and Take Immediate Action to Protect Students

**Washington, D.C.** — The American Association of University Women (AAUW) unequivocally condemns President Trump's executive order "Improving Education Outcomes by Empowering Parents, States, and Communities" dismantling the U.S. Department of Education.

"This reckless and shortsighted action threatens to gut vital protections that ensure equal access to higher education and will have devastating consequences for students — especially women, students of color, and those from low-income backgrounds — who rely on federal oversight for their right to an equitable education," said Gloria L. Blackwell, CEO of AAUW. "Eliminating the Department of Education would decimate federal civil rights enforcement, slash protections against gender-based discrimination, and roll back decades of progress toward making higher education accessible and affordable. This decision is not about streamlining government; it is about stripping students of their rights and futures."

Consequences of this action may include:


- Low-income students may lose vital federal financial aid that makes it possible to earn their degrees;
- Survivors of sexual harassment and assault on campus may see more Title IX cases dismissed and drastically weakened pathways to justice;
- Students with disabilities could be left without critical safeguards to protect and enforce their rights in schools.
- LGBTQ+ students who experience harassment and discrimination could face unsafe environments without their schools being held accountable;
- Student loan borrowers may be more vulnerable to abuse by predatory for-profit colleges and noncompliant servicers while facing unaffordable repayments;

AAUW urges Congress to speak out against this move and protect the Department from any further cuts that could hinder enforcement of federal civil rights laws protecting students and preserving access to higher education. The cost of inaction is too high, and the futures of millions of students — especially those from marginalized communities — hang in the balance.

In response to these coordinated and continuing attacks on education in America, AAUW is launching <u>The Defend Higher Education Fund</u> to enable AAUW to elevate the critical higher education issues impacting women, mobilize advocates across the country, provide strategic resources to students, staff and faculty on campus, and fuel investments in the infrastructure and technology necessary to move our mission forward.
